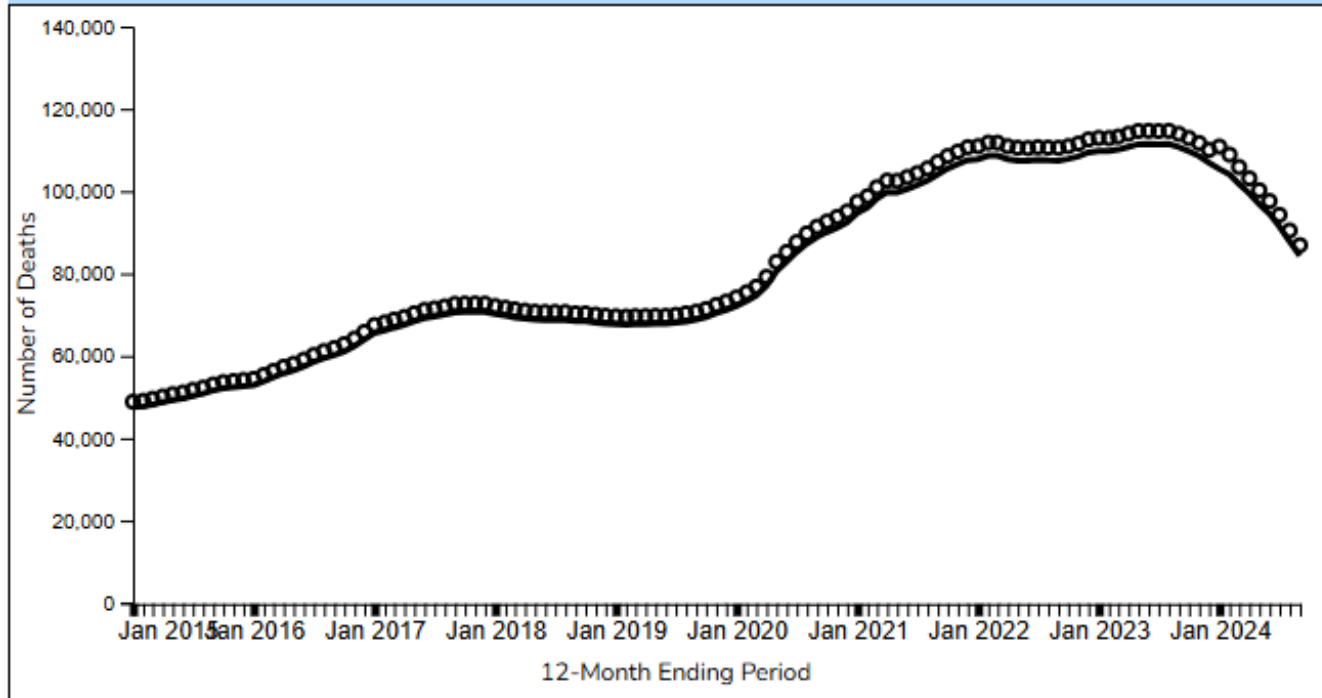

While there is still much work to be done to mitigate the ongoing drug epidemic, recent CDC data show encouraging trends nationally regarding drug overdose deaths.

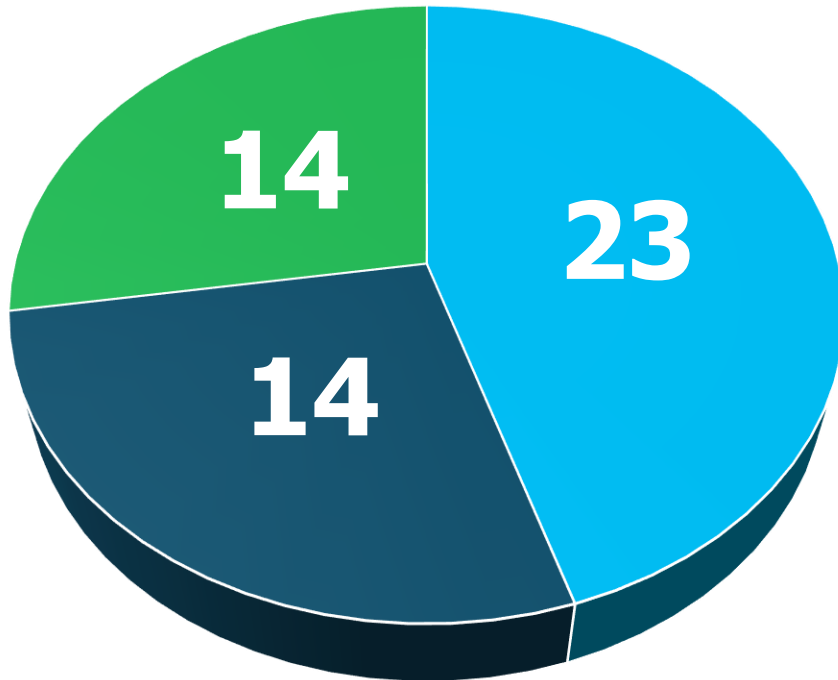

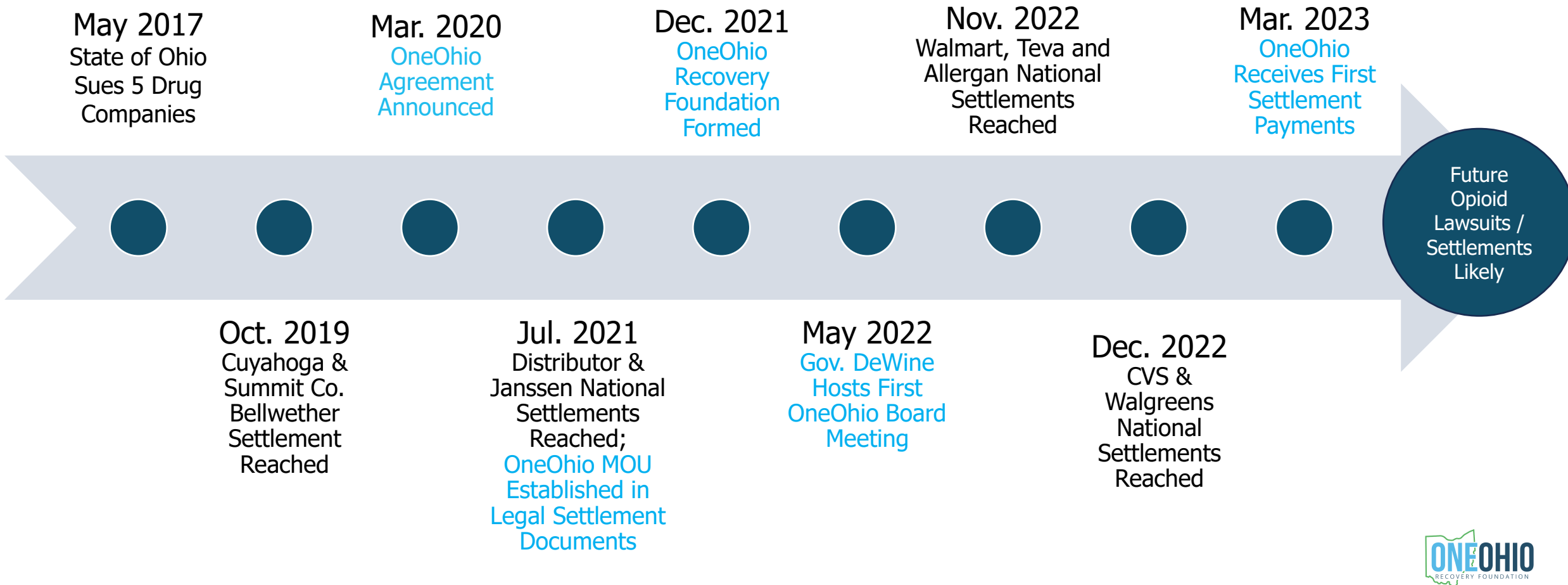

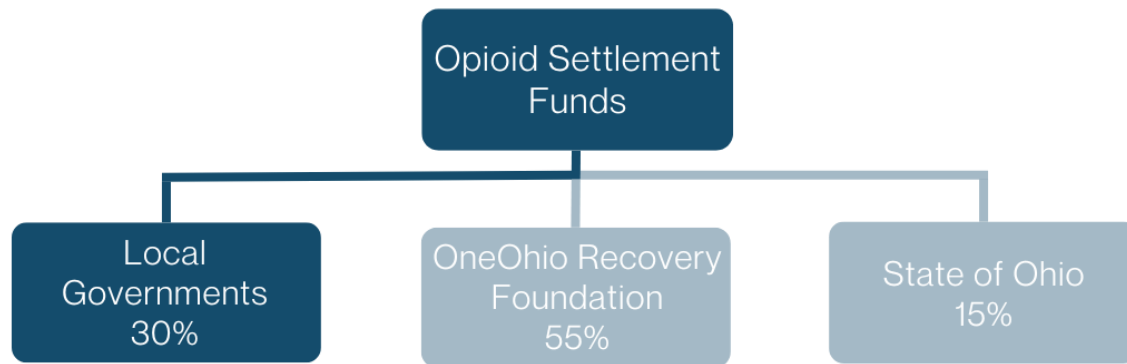

SUBJECT: OneOhio Opioid Settlement

Ohio reached an \$808 million agreement with the three largest distributors of opioids. The state developed the OneOhio plan, a mechanism to ensure that any money from a negotiated settlement is distributed fairly to the communities hit hardest by the opioid crisis.

The settlement agreement allocates 30% to local governments (LG Share), 55% to a foundation that will distribute funds to projects, and 15% to the Office of the Ohio Attorney General as Counsel for the State of Ohio. This bulletin will focus on the allocation of settlement proceeds provided directly to local governments in the LG Share.

The purpose of this bulletin is to emphasize the separate accountability and accounting guidance for the LG Share of the OneOhio Opioid Settlement Funds (OneOhio Funds).

Approved Uses of the Local Government Share

OneOhio Funds must be utilized in a manner consistent with the "Approved Purposes" definition in the OneOhio memorandum of understanding (MOU). According to the MOU, the Funds must be used for "evidence-based forward-looking strategies, programming and services used to (i) expand the availability of treatment for individuals affected by substance use disorders, (ii) develop, promote and provide evidence-based substance use prevention strategies, (iii) provide substance use avoidance and awareness education, (iv) decrease the oversupply of licit and illicit opioids, and (v) support recovery from addiction services performed by qualified and appropriately licensed providers[.]"

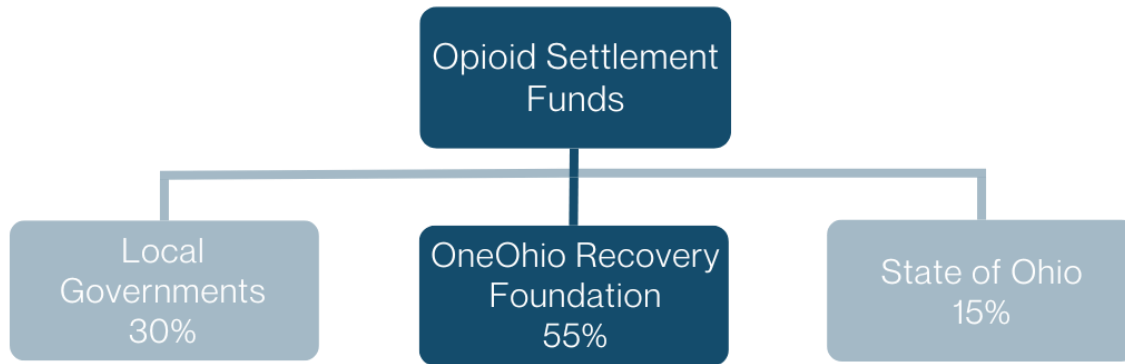

SETTLEMENT FUNDING

BACKGROUND

In March 2020, Ohio Governor Mike DeWine and Attorney General Dave Yost [announced](#) that local governments representing more than two-thirds of the state's population signed on to the OneOhio plan in order to jointly approach opioid settlement negotiations and litigation. The OneOhio plan provides a mechanism for the distribution of opioid settlement funds and outlines how those funds can be used. Specifically:



- **55% of the funding goes directly to the OneOhio Recovery Foundation** to develop and oversee the funding of short-term and long-term planning and supports that local communities need to continue to address this crisis.
- **30% of the funding goes directly to townships, villages, cities and counties** in Ohio to support community recovery and address the immediate needs of residents. These direct payments to local governments are separate and distinct from those managed by the Foundation.
- **15% goes to the State of Ohio** to be used to leverage statewide buying power to offer prevention, treatment and recovery support services. Direct payments to the state are separate and

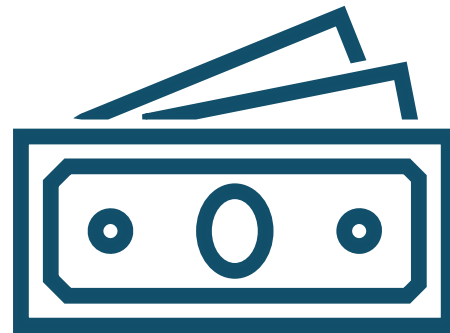
SUPPORTING GRANTEES

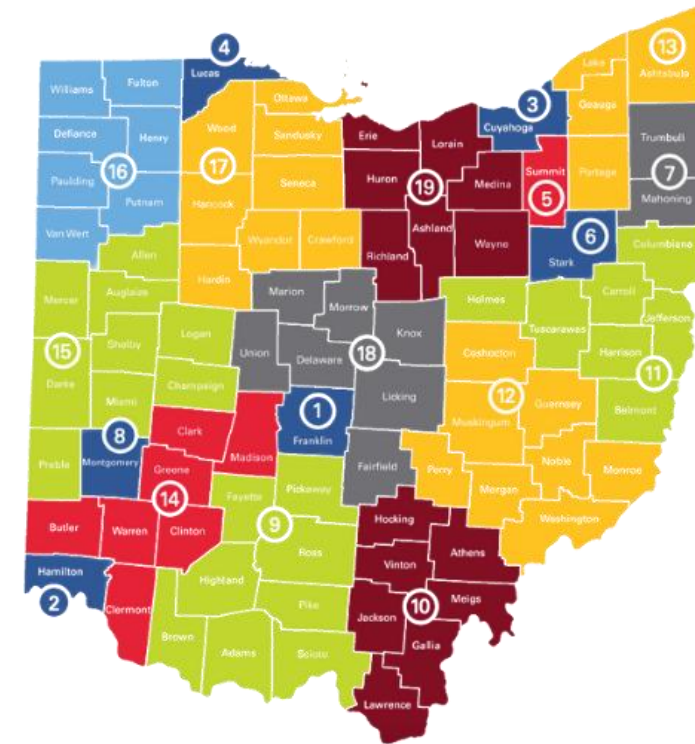

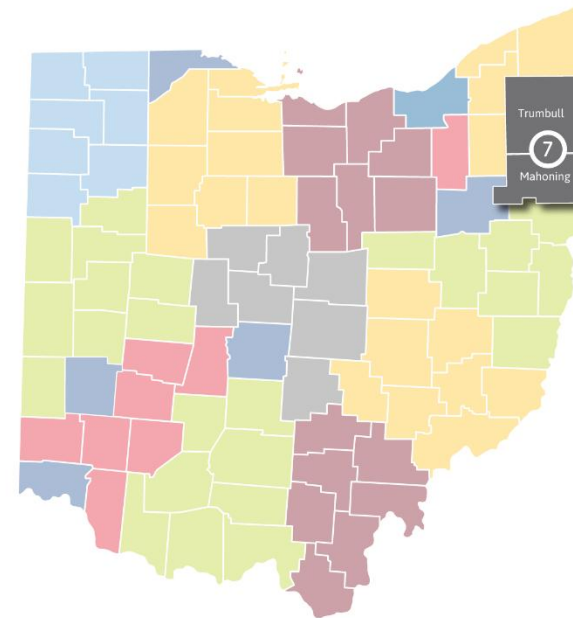

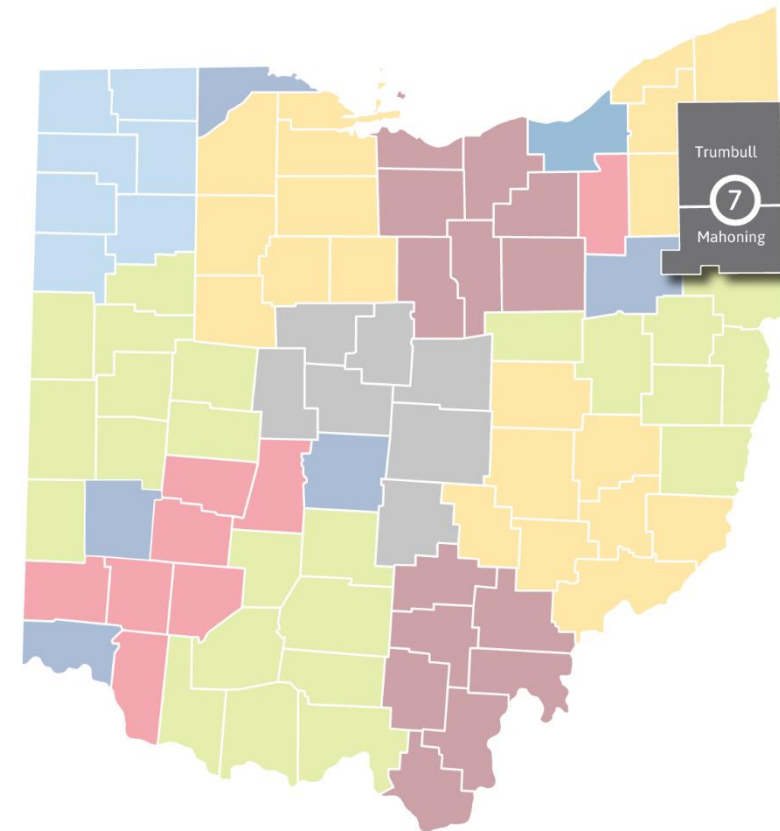

- **Get Involved:** Public health has a strong role to play in the OneOhio grant process.
- **OneOhio Staff Is Here to Help:** The Foundation's team is committed to ensuring the settlement dollars make an impact in our communities – and they show it through their work helping Regions and grantees along the way.
- **Think Big:** Grants allow innovation and can provide resources to projects not typically eligible for other funding.
- **Don't Force It:** Only apply for a grant when you're sure you're ready to take on a project.

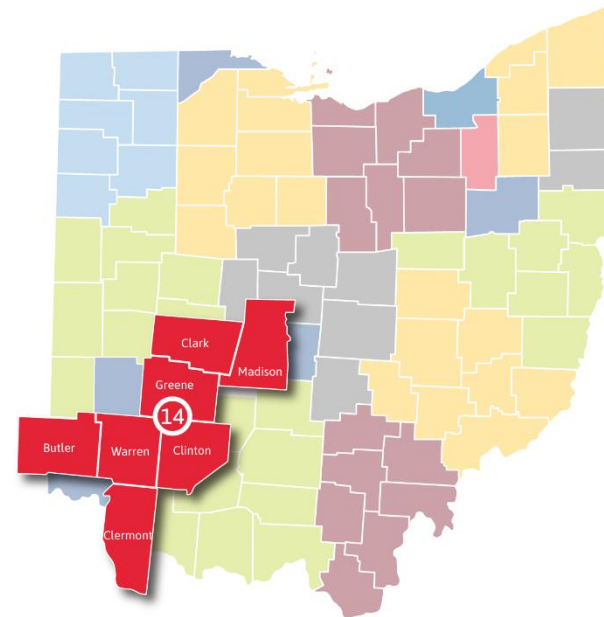

- **Grant Award:** \$225,000
- **Project Length:** 12 months
- **Grant Dollars in Action:**
Expanded mobile unit service acts as health and education hub while providing other resources, including food and transportation assistance.



WORDS OF WISDOM

- **Get Involved:** Engage with your Regional Board to understand the process and local priorities.
- **Fair Application & Reporting Process:** While daunting at first, OneOhio's application and grant reporting processes are fair and straightforward.
- **OneOhio Wants Us to Succeed:** Foundation's approach is supportive, not punitive. 800+ hours of technical assistance provided to help grantees with first round reporting.
- **I'll Say It Again -- Don't Force It:** Only apply when you know your project is ready for prime time.
